■ \$1.00/therm for projects that have annual savings greater than 7,500 therms;
■ Incentives are limited to a maximum of \$25,000 per project;
■ Incentive may not exceed 30% of the total project cost;
■ Incentive does not apply to projects with a simple payback less than 1.5 years.

Offer valid only for Citizens Gas natural gas business customers. Location of installed equipment must have Citizens Gas natural gas service under rate D3 or D4. Customer must be a US resident (including a U.S. resident alien) and must provide their correct taxpayer identification number. Incentive funds are limited and available on a first-come, first-served basis.

Verification: Citizens Gas reserves the right to verify sales receipts and/or installations of equipment and that the equipment installed meets program requirements before issuing rebates. A random inspection may be conducted to verify installations.

Program Modifications: Citizens Gas reserves the right to alter or discontinue these rebate offers at any time without notice. Financial incentives are limited and are available on a first-come, first-served basis.

Disclaimer: Citizens Gas does not guarantee that energy efficiency equipment purchased and installed or services provided through this program will result in energy and costs savings. Citizens Gas reserves the right to deny or limit any rebate request. In addition, no warranties on product or service installations are provided by Citizens Gas, nor does the program warranty, guarantee or endorse the energy efficiency services provided by any specific contractor participating in the program. Please allow up to eight (8) weeks to receive your rebate.

Eligibility Dates: This incentive form is only eligible for qualified purchases and installations performed on or after **September 1, 2009**. Citizens Gas reserves the right to alter or discontinue this program or related rebates at any time without notice.

- Before starting your energy efficiency project, the Citizens Gas customer must complete and submit this application directly to Citizens Gas for approval. Citizens Energy Savers Program incentives cannot be granted without prior completion of this application, and subsequent approval by Citizens Gas. Energy service companies or contractors may assist in preparing the application, but an authorized representative of the customer must sign this application to be eligible to participate in the Citizens Gas Energy Savers program. Completion of this application does not guarantee the approval of a Custom Incentive.
- Do not begin your energy efficiency project(s) or purchase equipment until you receive written approval in the form of a letter of Intent from Citizens Gas. The project should be completed within 90 days from acceptance.
- Once all documentation is received by Citizens Gas (a site inspection may be completed if necessary), Citizens Gas will indicate the anticipated Custom Incentive amount in an acceptance letter based on the projected energy savings. Upon completion of the project and verification of installation and operation of the energy saving measures, Citizens Gas will issue a Custom Incentive check in the amount indicated in the acceptance letter, or adjusted if the project varies from the information originally submitted.
- Depending on the scope or cost of your energy efficiency project, Citizens Gas, may conduct an inspection of the facility. The customer agrees to allow subsequent site visits, if needed, to verify installation and operability, prior to Citizens Gas issuing the Custom Incentive check.
- Customers are encouraged to retain copies of all forms, invoices and supporting documentation for their records.

Taxes: Incentives are taxable and if greater than \$600 will be reported to the IRS unless you are exempt. Citizens Gas will report your rebate as income to you on IRS Form 1099 unless you have checked corporation or exempt status above. You are urged to consult your tax advisor concerning the taxability of rebates.
