



## Application for Residential Appliance/Product Rebates and New Construction

Please verify that the following requirements are met before submitting your application.

### Rebate Requirements

1. Applicant must be a Citizens Gas natural gas residential customer and location of installed equipment must have Citizens Gas natural gas service. (Rate D1 or D2) (Westfield area customers are not eligible.)
2. All applicable fields must be completed on the form to receive a rebate (installation address is required).
3. **A copy of the customer's invoice(s) must be stapled to the back of this form.**
4. Equipment must be purchased October 1, 2008 or later. The rebate form and invoice(s) must be postmarked within 30 days of the appliance/product purchase. (Rebate funds are limited and available on a first-come, first-served basis.)
5. An eligible customer may receive a rebate for each eligible appliance/product installed.
6. Please allow up to eight (8) weeks to receive your rebate. Incomplete rebate forms will not be processed.

## Contractor Instructions

Verify that customer's natural gas utility at the installation address is Citizens Gas.

High Efficiency Natural Gas Furnace and/or Water Heater: Installers are required to implement the following measures to qualify furnace and/or water heater installations for rebates:

Chimney liners must be installed where atmospherically-drafted equipment remains in the residence. Installers must complete flue closure protocol where a high efficiency furnace and/or water heater is installed and the chimney has no other use; where the water heater is power vented through the sidewall or is fueled by electricity (refer to flue closure protocol); The furnace must be a sealed combustion unit with combustion air supply provided from outside the home to reduce whole-house air infiltration.

## Tax Info for 1099 Forms

**Taxes:** Incentives (residential applicants excluded) are taxable and if greater than \$600 will be reported to the IRS unless you are exempt. Citizens Gas will report your rebate as income to you on IRS form 1099 unless you have checked corporation or exempt status on this form. You are urged to consult your tax advisor concerning the taxability of rebates. ## Terms for Adoption of ENERGY STAR Standards

1. Builder must submit a copy of an authorized ENERGY STAR new home energy rating certificate from an authorized ENERGY STAR provider/rater.
2. Home must have HERS rating of 85 or less for ENERGY STAR.
3. Home must attain a HERS Index rating <70 for ENERGY STAR Plus.
4. Home must utilize natural gas for all water and space heating needs.
5. Natural gas furnace must be minimum 92% AFUE.
6. Natural gas storage tank water heater must be 0.62 EF or higher.
7. Natural gas tankless water heater must be 0.82 EF or higher.
8. Please note there is a maximum of 15 ENERGY STAR home rebates per builder per calendar year.
9. ENERGY STAR and ENERGY STAR Plus are open to owner occupied attached units up to six (6) units per building.
10. Builder must meet all HERS Requirements to meet the Federal Tax Credit for new homes, when applicable.
